- Payment in full is required to reserve space
- No food vendors or car apparel vendors
- Covered Shelter space are reserved for craft booths only, unless approval by show promoter
- Personal or Business checks, cashier's checks, money orders or cash will be accepted.
- Vendors will receive a confirmation card by mail; vendor packets can be picked up at event site.
- Vendor/Exhibitor will receive two admission passes and one vendor car pass. Extra Vendor Passes will be \$5.00 each
Vendor Parking will be designated
- Security will be on site nightly from 6:00 pm until 8:00 am the next day
- Setup/Hours of Operation/Teardown Setup Dates: Monday, Tuesday, Wednesday, August 9, 10, 11, 2011 8:00am – 5:00pm Show Dates: Friday and Saturday, August 12, 13, 2011 8:00am – 5:00pm
- All trash and debris must be removed from site before departure
- Food or beverage items cannot be sold at GA MTN Moonshine Cruiz-In, as food vendors are already reserved
- No apparel of any kind can be sold at the event site EX: T-Shirts, Sweatshirts, or Caps, unless written approval by promoter
- Swap Meet spaces are reserved for used automotive merchandise only.
- We understand that many of our vendors have pets that travel with them. The Georgia Mountain Fairgrounds does not allow pets on the property, sorry for the inconvenience. Please make arrangements for your pets.
- Georgia Mountain Moonshine Cruiz-In will distribute state tax information prior to the commencement of the event. Vendors will have all documents and will be required to fill out and send to GA Department of Revenue
- Solicitation and selling items outside your area is not permitted
- Parking nearby will provided for crafters/vendors
- All booths are required to maintain a fire extinguisher at all times
- Exhibitors cannot sublet or apportion space to anyone else
- GMMCI will provide nightly security, but is not responsible for lost, stolen or damaged goods
- Vendor agrees to comply with all laws, licensing, permits, and health regulations. Vendors are solely responsible for payment of local & state sales tax due as a result of any sales made during this event.
- The sale and/or display of merchandise bearing the words Georgia Mountain Moonshine Cruize-In, as well as any other printed variation of these trademarks, to this specific event is strictly prohibited. Any vendor or merchant found selling merchandise that infringes on these trademarks will be subject to legal recourse and immediate termination of this agreement.
